Sponsor is to call ahead of time to let Owner know of arrival and to check availability. Owner will make all attempts to not use Sponsors horse for trail rides or lessons, but if Sponsors horse is needed as a last resort, Owner has the right to use. In exchange for every pre-scheduled reserved time slot, Sponsor does agree to assume care for the Adopt/Sponsored animal that is consistent with the practices of good animal husbandry and ranch rules. This consists of capturing sponsored horse, bathing, grooming and riding as frequently as possible. The purpose of said care is to insure the well being of the sponsored animal and to help the Sponsor develop a bond between himself/herself and the sponsored animal.

Owner/Agent agrees to provide appropriate medical care, housing facilities and farrier expenses of said animal and that the animal is in good health prior to the signing of the contract.

The Sponsor agrees to provide his/her own tack (saddle, bridle, blanket, harness, lead rope, etc.) after or before Staff hours, which are 8 am to 5 pm. After 5 pm, Sponsor must bring their own tack. Special snacks or food MUST be preapproved with staff before given to the horse.

Hours Sponsor can be on the property are Monday – Sunday 8am – 10pm. If Sponsor would like to ride after dark, they can only ride in the arena. Gate will be locked after 6:00 pm and Sponsor has to park up front and walk back to the barn.

Liability and Trail – Forms must be read, acknowledged and signed. Owner/Agent will hold Sponsor responsible for any damages that occur due to inappropriate handling/care of said animal while in their possession. Value of aforementioned animal or medical costs will be determined by an independent source (veterinarian and/or appraiser). If sponsored animal dies due to natural causes, Owner/Agent will incur the cost of disposing of the said animal.

Sponsor may not sublease aforementioned animal without the direct knowledge of Owner/Agent. Any changes of the contract must be in writing and agreed to by both parties. Sponsored animal may never leave our premises without written permission.
